## Day Surgery Unit transformed

Flexibility is the main objective of the refurbishment of the Day Surgery Unit, which was funded by the NHS and came back into use on 3 May.

The unit is now able to maintain gender segregation on a flexible basis, since there are now two large access doors, two toilets (one on each side of the unit) and the beds, of which there are seven, can be moved within

the unit to respond to the numbers of women or men present. Eight patients are seen during a typical day.

The most conspicuous feature in the unit is its new glass-enclosed sitting area [see main photo]. When patients first arrive they will sit here while paperwork is completed. In due course they will occupy a bed and be wheeled the few feet to the operating theatre. On return to the unit from Recovery they will rest in bed before later transferring back to the sitting area where they can easily be fetched for the trip home.



A further major change from the previous provision is the much smaller nurses' station [on left in main photo]. This is now a modest crescent, very accessible to patients if need be. Staff expect to be on the move round the unit much of the time, and to facilitate their

care of the patients they have a laptop cart [photo bottom left], so that the patients' details can be viewed and recorded anywhere on the unit and at the bedside, without the staff needing to return to the station.

There are easily accessible hand basin points. The whole unit is fresh and bright and the walls are lined with wipe-down surfaces making infection control much

easier to achieve.



Day Surgery can include a wide range of procedures including laparoscopic gynaecological work, orthopaedics in the form of arthroscopy on knees for example, maxillo facial procedures and general surgery which includes the repair of inquinal hernias or carpal tunnel work.  $\square$

### Report of the Trustees

The trustees present their report along with the financial statement of the charity for the year ended 31 March 2017. The financial statements have been prepared in accordance with Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland published on 16 July 2014.

### <u>Objectives and activities for the public benefit</u>

The object of the Friends is to "support patients of the hospital and others in the community who are in need of health care as may be provided by the hospital and generally to support the work of the hospital."

All our activities support this NHS hospital's work, a service of care which is available equally to all members of the local community. The Friends' aims are to respond to the needs of the patients in the hospital and the community where appropriate, and to supplement those facilities and services in the hospital which will enhance their health, welfare and comfort. All this is demonstrably for the public benefit.

### Grant making policy

Funding is considered for projects providing they meet the following criteria which are to:

- \* ensure continuity of current services
- \* enable additional services to be provided locally
- \* add to the well-being or treatment of patients, or working conditions of staff
- \* enhance the hospital or community environment
- \* improve care through staff training.

The hospital management initiates requests for grants. The Friends consider the views of clinicians on the benefits of medical equipment, and from the hospital management they require a sound business case which confirms that the equipment will answer a need and be put to regular, beneficial use.

### Achievements and performance

The Friends sought contributions from individuals and organisations by way of subscriptions, donations and legacies. Funds increased very helpfully. Our own PR team staged frequent local events, we published a newsletter and maintained a high profile in the locality.

A membership of about 1,100

provided a dependable flow of income.

### Objectives for 2016-2017

- Promote fund raising
- \* Liaise with the Dorset HealthCare NHS Trust and the Dorset Clinical Commissioning Group over services, developments at the hospital and the Clinical Services Review
- \* Act as an advocate for community opinion on local healthcare
- \* Fund staff training through Phyllis Coombes Award grants
- \* Fund acquisition of equipment
- \* Administer the Friends' charity shop
- \* Support trolley and card stall services in the hospital
- \* Maintain and support volunteers

### <u>Liaison with Dorset HealthCare NHS</u> Trust

Meetings were held with senior managers in the Trust at local and Dorset level to discuss possible changes to services at the hospital. Hospital Matron attends meetings of the trustees' committee.

### Hospital Staff Training

Through the Phyllis Coombes Award 25 staff were funded for 17 courses, involving a cost of £3,888.

### Grants for Equipment

The Friends committed £12,805 to purchasing new equipment. This sum covered several items for the new Minor Injuries Unit and the purchase of Digital Reminiscence Therapy software.

### Charity Shop

The shop maintained its income level of the previous year, but economic times are not easy. Retail Gift Aid is now firmly established with 454 registered donors. In its fourth year the scheme created over £3,000 in claimable gift aid and 25% of all items sold were gift aided

### Trolley & Cards Services

The trolley service and card stalls in the hospital provided much-appreciated items for patients, visitors and staff. The trolley service contributed £400 to the Friends during the year and impressively the card stalls were able to transfer £8,000 to the Friends from their trading.

### Financial Review

### Reserves Policy

The Committee's policy is to keep funds to a minimum of £100,000

accessible for equipment purchase. Undesignated and unrestricted funds totalled £3,016,057 at the year end. (Please refer to the Plans for the Future) We do not currently have any designated or restricted funds.

Alternative financial arrangements are kept under constant review; the security of our funds is the trustees' top priority. No funds are held in market-based investments. Funds are held on deposit with a range of different providers to spread any risk. The Friends do not employ any investment adviser or agent.

### Budgeting:

The Friends' expenditure on major items is entirely driven by the hospital's requirements. Since this is outside the control of the Friends, we do not budget in a conventional sense. We build up capital in anticipation of applications for grants. Grants may range in size from less than £1,000 to many tens of The Friends' largest thousands. contribution in recent years was to pay £2.7 million (95% of the total cost) in 2009-2010 towards the rebuilding of the operating theatre. Future developments could require financing by similarly large sums.

### Risk Management

The charity trustees considered the risks to which the charity is exposed, reviewed those risks and established systems and procedures to manage them. They did not identify any major risks

The most serious risk to the charity's objectives would be policy changes at various levels of healthcare organisation which led to the closure (or radical downgrading) of the hospital. We cannot influence decisions at governmental level, but do exert pressure where appropriate on the local healthcare trust and the Dorset Clinical Commissioning Group.

Secondly the failure of financial institutions could threaten our capital funds. We diversify our deposits, thus minimising risk as far as feasible.

### Website:

The Friends operate a website, which is used by slowly increasing numbers to communicate with the Friends and to inform themselves about our charity. This website is hosted by a secure server and access is securely passworded. Viewers can make single or regular donations through the website.

### Going Concern:

There is currently no uncertainty about the charity's ability to continue as a going concern. The Friends function on minimal running costs and own no property nor have any ongoing commitments. The trustee officers are all volunteers and receive no remuneration. The two managers in the charity shop are paid from the shop's operational funds which produce a surplus. Lively fund-raising activities ensure a high profile for our charity which enjoys enduring local support. This last element most significantly ensures the future of the charity.

### Sources of Income

Legacies, usually the greatest source of income, again proved most helpful, including several large bequests. The shop surplus and members' subscriptions provided a regular and significant income which could be roughly predicted. Donations and legacies in particular are entirely unpredictable, but are most gratefully received.

#### Volunteers

With the exception of the shop managers, all trustees and personnel who work for the FVHW do so as volunteers. They contribute over 6,500 man-hours to the charity every year. Their contribution is indispensable to both the daily running and special events of the Friends and is most warmly appreciated. We are also grateful for the support of many individuals who give their time and commitment on an occasional basis.

### <u>Structure, Governance and</u> Management

The Trust is a Society which is a registered charity (Number 299230) and whose business is conducted and managed by its Committee of Trustees. The charity is governed by rules adopted in 1950, as amended 20 June 1959, 27 June 1990 and 24 June 1992. A revised Constitution was approved at the Annual General Meeting in July 2009.

New trustees are given an induction when they undertake their

responsibilities. The committee has the power to appoint new trustees as vacancies arise and gives due regard to the requirement for any specialist skills required at that time.

The trustees' names are listed overleaf.

### Plans for the Future

In the year the Friends accumulated further funds for use as needs in the hospital arise and to support the introduction of procedures and services. This may be with new equipment or with improvements to the design and fabric of parts of the buildings. In the longer term, as seen in the "Core Strategy" Policy WMC3, changes in land use adjacent to the hospital's current site may present opportunities for future expansion and development with attendant high costs.

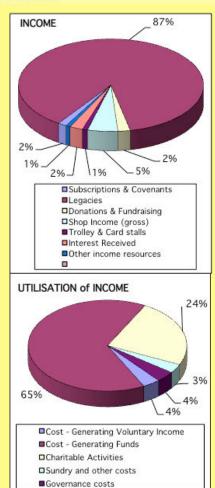
The outcome of the Dorset *CCG's* review of clinical services aims to increase locally based care. This may influence the use of our grants.  $\square$
